Document Certified

1. Certified Proof of Identity

A copy of your Passport, National Identity Card or Drivers License, certified as a true copy of an original document by an Approved Certifier*.

2. Certified Proof of Address

A secondary identification document which must be certified as a true copy of an original document by an Approved Certifier*, e.g.

- a. A notice that was issued to an individual by the Commonwealth of Australia, a State or Territory of Australia within the preceding twelve months; which contains the name of the individual, his or her residential address; and which records the provision of financial benefit to the individual under a law of the Commonwealth of Australia, State or Territory (as the case may be).
- b. Notice of Assessment issued by the Australian Taxation Office within the preceding 12 months.
- c. Utilities or municipal rates notice that was issued to an individual by the provider within the preceding three months which contains the name of the individual and his or her residential address; and which records the provision of services by that local government body or utilities provider to that address or to that person.
